The industry needs to be ahead of the game by putting some thought into how to prevent this kind of scenario being played out for real.

I would encourage everyone here to make a mental note of this point and maybe base some of the discussions taking place on this topic. I am sure this will lead to some interesting discussions and will give a lot of people a fresh train of thought. I hope everyone will enjoy the conference.

She has 14 years' experience in the research and simulation of human behaviour and completed an award-winning PhD in evacuation modelling. Aoife advises on the movements and behaviour of people in tall buildings, hospitals, stadia and events, the public realm, and transport systems across the world. She leads national research projects to advance the safety and security of crowded places, specialising in human behaviour in emergencies and pedestrian movement through security overlays. Aoife is regularly consulted on national guidance documents and is currently co-authoring the chapter on evacuation modelling in the SFPE Fire Engineering handbook. Aoife is co-chair of the Security Institute's Special Interest Group: "Protecting People in Crowded Spaces" and an Adjunct Professor at the University of Maryland.

David Lowe joined the Metropolitan Police in 1992 and served in numerous operational roles, specifically specialising in public order policing across London. He transferred to Northamptonshire Police in 2000 and specialised in major incident and disaster management. He is a qualified public order, firearms, pursuit and CBRN commander.

Having over 30 years of experience across policing, major incidents, disaster and crisis management, he is currently employed as the Training and Development Manager for the UK in Counter Terrorism against Chemical, Biological, Radiological and Nuclear (CBRN) threat.

David holds qualifications and experience in the design, development and delivery of training programmes to high national and international standard, including command training at Strategic & Tactical levels for all UK emergency services and specialist military capabilities. He has provided bespoke designed training for the United Nations, Office for Disarmament Affairs and the Organisation for the Prohibition of Chemical Weapons, on behalf of the UN Secretary General.

David is registered as a subject matter expert in numerous national and international programmes concerning terrorist threat and has served as an advisor at multiple strategic coordination groups, most recently including the chemical releases in Salisbury, UK.

In 2021 David registered a business interest as a consultant in Crisis Leadership for the private sector, specialising in tall & complex buildings, bringing the experience of emergency services crisis leadership into the private sector. Since then he has provided a programme of crisis leadership development for numerous tall and complex buildings across the UK.

David focusses on key decisions by senior leaders in crisis situations, how to ensure their rationale is documented, how to weigh up ethical considerations and most importantly ensure your management of crisis can withstand retrospective legal scrutiny.

FIGEN MURRAY OBE

Figen Murray is the mother of Martyn Hett, who at 29 years of age was tragically killed alongside 21 others at the Manchester Arena terrorist attack in May 2017.

Since the Manchester Arena attack, Figen has been working with the Government and the security industry to make the tangible changes that can help ensure no other family has to go through what hers has. She is the force behind Martyn's Law (Protect Duty), a legislation requiring publicly accessible locations to improve security against the threat of terrorism. Her ambitions to better understand counter terrorism saw her achieve a distinction in a counter terrorism master's degree from the University of Central Lancashire.

Figen's dedication and work in counter terrorism saw her awarded an OBE in the 2022 New Year's Honours List.

MIKE BLUESTONE MA CSyP FSyl

Mike is an award winning security professional who has served in the military both in the UK and overseas. He has held senior positions in security management for over thirty years including several years as Head of Security for a national community security organisation. In 2009, Mike founded Corps Consult, the consulting arm of Corps Security, where as Executive Director, he delivers security solutions to a wide sector of businesses and organisations in both the public and private sectors.

With a Masters degree in Security Management awarded by Loughborough University, he is a Chartered Security Professional, and a Fellow and Chair Emeritus of the Security Institute, and a member of the London Resilience Academic Partnership. Mike chairs the Security Management committee of the British Standards Institution (BSI) where he led the development of BS16000 'Security Management and Operational Guidelines'. He is also a member of the BSI Security Strategy Group, and an Ambassador to the Register of Chartered Security Professionals, and the accredited trainer in Security Management and Resilience for the IWFM Academy. Paul is a Fellow of the Institute of Strategic Risk Management (F.ISRM) a member of the Security

Institute (Syl) and a member of the Executive Leadership Team at the City Security Council. His expertise includes design and delivery of complex risk, counter-terrorism and security solutions and public-private collaboration.

Paul has delivered security solutions to tall buildings such as The Shard, 20 Fenchurch Street, Tower 42, 100 Bishopsgate and CityPoint, to name but a few. Paul business career spans 30 years in Executive Board roles in plc listed, private equity and privately owned businesses up to £750m.



NICK ALDWORTH

Nick Aldworth retired from a 36 year career in the military and policing in May 2019. Across that time he enjoyed multiple operational roles, with the last 5 years serving within counter-terrorism (CT) and retiring as the UK's CT National Coordinator for Protect and Prepare. He was responsible for making

the UK stronger against terrorism and more resilient to its impacts.

On retirement, Nick joined forces with Figen Murray, whose son was murdered in the Manchester Arena attack, and Brendan Cox, the husband of Jo Cox MP, in campaigning for the UK Protect Duty, and he was the author of the proposal on which the government has recently consulted. Now known as Martyn's Law, the legislation was given approval to go before Parliament, just before Christmas 2022.

Nick runs his own company, Risk to Resolution Ltd (R2R), that aims to help organisations identify the challenges they face, and support them, and their staff, in resolving them.



RICHARD GALVIN

Richard Galvin was a highly respected, top-performing senior leader with over 30 years' experience in the City of London and Metropolitan Police Services, attaining the rank of Chief Inspector Specialist Operations. Richard was a Tactical Firearms Commander, a Public Order Silver and Bronze

Commander and a CBRN(e) Tactical and Operational Commander specialising in assessing and mitigating risk, crisis management, commanding and controlling incident response and managing Policing operations in London. As a public order Police commander, Richard was a scene commander at Borough Market and Parsons Green Terrorist attacks in 2017 working in collaboration with other emergency responders to manage crises that required immediate intervention to protect public safety, deployed as a bronze commander during President Trump visit to the United Kingdom, a highly complex and multifaceted operation that involved a wide range of security measures and protocols and was one of three bronze commanders to implement Section 14 Public Order conditions on a public assemblies during Extinction Rebellion protests in central London in 2019 that required a strategic and co-ordinated policing operation whilst balancing the rights of the protestors and the human right implications. A match Commander at Wembley, Tottenham and the Olympic Stadium he was recently commended for his leadership and professionalism during the Euros 2020 when faced with violent disorder in central London.

On retiring from the Police Service, Richard was head hunted by CIS Security Limited and joined them in 2021 as Head of Security at the Leadenhall Building. As a result of his expertise and experience he soon became their subject matter expert on Tall Buildings, Crisis management and Incident Command. During his tenure he has overseen training and emergency response to critical incidents in tall buildings providing training to senior managers regarding decision making and recording decisions during a crisis situation and provided security advice around "Urban Explorers" to the High-Rise Interactive Group (Hi-Rig) - a group of Estate directors and facility managers from London's most iconic buildings and property groups.
